Local Expert Awarded Top National Honor for Saving One of Largest Agricultural Supply Co-ops in US

Colleagues Honor Clyde Hamstreet with 2005 Turnaround of the Year Award

October 14, 2005, Portland, OR - For the second time in eleven years, the Turnaround Management Association (TMA) will honor Portland-based turnaround expert Clyde Hamstreet with the highly coveted 2005 Turnaround of the Year award at this year's international association convention, October 18-21, in Chicago. At no other time in the Association's history has the same member won top honors more than once for his outstanding turnaround work.

Every year, the TMA's 7,000 members in 34 regional chapters are eligible to be nominated for their outstanding turnaround results. This year, six individuals, along with a team of corporate renewal professionals, were selected in five categories for Turnaround of the Year awards. Of these categories, Mr. Hamstreet won the Mega Company Turnaround award (\$1 billion USD or greater in revenue at the onset of the turnaround).

In 1994, Mr. Hamstreet received the Practitioner of the Year award. This year's award acknowledges his efforts in successfully restructuring the Southern States Cooperative (SSC), one of the largest agricultural supply cooperatives in the United States, with over \$1.5 billion in revenue and almost 5,000 employees.

SSC engaged Glass & Associates in September 2002 to restructure the company and provide financial advisory services. As Chief Restructuring Officer, Clyde Hamstreet headed up the Glass team and worked alongside SSC's new management, instituting a 120-day survival strategy followed by a longer term, five-pronged strategic plan. Ultimately, as a result of a myriad of efforts, SSC returned to profitability in fiscal year 2004 with earnings of \$67 million. Dennis Ladd who assisted Hamstreet in the engagement is also receiving the award.
